Appointment of a new custodian

IOOF Investment Management Limited (IIML) as Responsible Entity has appointed Australian Executor Trustees Limited (AETL)¹ as a custodian for managed investment trusts (Trusts) from 30 June 2019. A list of the Trusts can be found below.

The role of a custodian is limited to holding the underlying assets of the Trusts and to carry out proper instructions as agent of the Responsible Entity. The custodian does not have a supervisory role in relation to the operation of the Trusts and it remains IIML's obligation to monitor and protect unitholders interests. IIML has the discretion to change and appoint additional custodians at any time.

IIML and AETL are entities within the IOOF Group consisting of IOOF Holdings Ltd, ABN 49 100 103 722, and its related bodies corporate. AETL is entitled to a fee paid by IIML for providing custody services.

This change has no impact on unit holders' investment in the trusts. Unitholders do not have to do anything as a result of this change.
